

'LivinnX Five' Competition Regulations (hereinafter referred to as the Rules)

§ 1 General provisions

1. These Rules and Regulations define the terms, course and conditions of participation in the "LivinnX Five" competition, hereinafter referred to as the "Competition".
2. The competition is organised by the Andrzej Frycz Modrzewski Krakow University, 1 Gustav Herling Grudziński Street, 30-705 Krakow, hereinafter referred to as "KA AFM" or "Organizer."
3. The competition participant can only be an adult natural person with full legal capacity, hereinafter referred to as: "Participant".
4. The founder of the prizes in the Competition is a company under the name of: SH GGH Management & Limited liability company with a limited partnership, with its registered office in Warsaw, 53 EmiliaPlater Street , 00-113 Warsaw, entered into the Register of Entrepreneurs of the National Court Register kept by the District Court for the Capital City of Warsaw in Warsaw, 12th Commercial Division of the National Court Register under the number (KRS) 0000572571, taxpayer identification number, NIP: 5223036641, National Business Registry Number, REGON: 362345709, hereinafter referred to as: "Founder".
5. The competition consists in the selection by the Organiser of 2 persons from among those enrolled in the list of first year students of the first degree programme or master's degree programme conducted at the Andrzej Frycz Modrzewski Krakow University in the full-time mode with the best result from this year's secondary school graduation (baccalaureate) examination, and 1 person from among those students who completed within the prescribed period at least the first year of full-time studies at the Andrzej Frycz Modrzewski Krakow University with a high average score and achievements, and subsequently in awarding prizes by the Founder.
6. The duration of the Competition covers the period from 19.07.2022 to 15.09.2022.
7. The Competition is not a game of chance, mutual betting or a game on slot machines, the result of which depends on chance within the meaning of art. 2 of the Act of 19 November 2009 on Gambling (Journal of Laws 2019, item 847).

§ 2 Competition task

The task of the Contestant is to apply for the participation in the Competition by providing:

- 1) results in this year's high school graduation examination (in at least 3 extended level subjects) or
- 2) the high average grade in the winter semester of the academic year 2021/2022 and outstanding achievements.

§ 3 Prizes

1. The following prizes will be awarded in the Competition:

1) for 2 persons from among those enrolled in the list of first year students of first degree studies or master's degree studies conducted at the Andrzej Frycz Modrzewski Krakow University in full-time mode:

a) providing accommodation in Livinn X Kraków located at 4 Tadeusz Romanowicz Street, Krakow, a private student house , in a separate room in a three-person unit (3x2P) in the period from 01.10.2022 to 31.07.2023 and reducing monthly accommodation fees:

1. **one-time administration fee for LivinnX Krakow-E100**(in words one hundred EUROS)
2. **monthly rent for accommodation** - 1 EURO per month (in words: one EURO 00/100) and
3. **additional monthly fee** - PLN 150.00 per month (in words: one hundred and fifty PLN 00/100).

2) for 1 person who has completed within the prescribed period at least the first year of studies at the Andrzej Frycz Modrzewski Krakow University:

a) providing accommodation in LivinnX Krakow located at 4 Tadeusz Romanowicz Street in Krakow, a private student house of high standards , in a separate room in a three-person unit (3x1P), in the period from 01.10.2022 to 31.07.2023 and reducing monthly fees for accommodation:

1. **one-time administration fee for LivinnX Krakow-E100**(in words one hundred EUROS)
2. **monthly rent for accommodation** - 1 EURO per month (in words: one EURO 00/100) and
3. **monthly additional fee** - PLN 150.00 per month (in words: one hundred and fifty PLN 00/100).

2. In order to provide the accommodation referred to in para. 1, the Founder shall conclude separate agreements for the rent of a room in a student dormitory with the Competition winners, subject to the provisions of this paragraph.

3. The condition for the prize referred to in para. 1, item 1 is that the winner of the Competition undertakes a full-time course of study at the Andrzej Frycz Modrzewski Krakow University in the academic year 2022/2023. If this condition is not met, the winner loses the right to the prize.

4. The condition for the award referred to in para. 1, pt. 2 is that the winner continues studies in a full-time course of study at the Andrzej Frycz Modrzewski Krakow University in the academic year 2022/2023. If this condition is not met, the winner loses the right to the award.

5. The right to the prize referred to in paragraph 1 point 1 and point 2 expires on the day:

- 1) a decision has been taken to strike a student off the list of students,
- 2) a decision imposing the disciplinary penalty of expulsion of a student from KA AFM has been issued,
- 3) the student's written resignation from the course of study has been submitted,
- 4) the student moves to another higher education institution.

6. If the right to the award referred to in section 5 expires then §7, section 6 of these Regulations shall apply accordingly.

7. Participants shall not be entitled to demand that the prize be exchanged for another prize or a cash equivalent.

§ 4 Competition participation criteria

1. The award referred to in § 3 section 1 item 1) may be applied for by a person who:

- 1) is a Polish citizen and has been enrolled on the list of first-year students of the first degree programme or of single master's degree programmes conducted at the Andrzej Frycz Modrzewski Krakow Univeristy on a full-time basis;

2) has their permanent place of residence outside the Municipality of Krakow and outside the adjacent municipalities of: Zielonki, Michałowice, Kocmyrzów-Luborzyca, IgołomiaWawrzeńczyce, Niepołomice, Wieliczka, Świątniki Górne, Mogilany, Skawina, Liszki, Zabierzów, Wielka Wieś;

3) took for the first time a written part of the high school graduation examination in 2022 and passed the examination in at least 3 subjects at the extended level.

2. Submitting an application for participation in the Competition, the sample of which is specified in Appendix 1 to these Regulations, constitutes the condition for taking part in the Competition and applying for the prize.

3. The incomplete applications, submitted after the deadline or by an unauthorized person will not be taken into account.

4. If the number of persons meeting the criterion referred to in § 4 paragraph 1 point 3 is greater than the number of prizes to be distributed, priority in obtaining the prize is given to the first two persons who have successively obtained the highest number of percentage points according to the ranking list.

5. The ranking list of persons is drawn up on the basis of the sum of percentage points from the items referred to in § 4, paragraph 1, point 3 from among the persons who submitted an application for participation in the competition.

§ 5

1. The award referred to in § 3, section 1, subsection 2) may be applied for by a KA AFM student who:
(1) has completed at least the first year of full-time study within the deadline;

(2) has a permanent place of residence outside the Municipality of Krakow and outside neighbouring communes of: Zielonki, Michałowice, Kocmyrzów-Luborzyca, IgołomiaWawrzeńczyce, Niepołomice, Wieliczka, Świątniki Górne, Mogilany, Skawina, Liszki, Zabierzów, Wielka Wieś;

(3) obtained in the winter semester of the academic year 2021/2022 a high average score of not less than 4.5,

(4) meets at least one of the following conditions:

(a) has an outstanding scientific, artistic or sports record,

(b) is an active member of the student council, scientific club or other student organisation.

2. Submitting an application for participation in the Competition, the sample of which is specified in Appendix 2 to these Regulations, constitutes the condition for taking part in the Competition and applying for the prize.

3. Incomplete applications, submitted after the deadline or by an unauthorized person will not be taken into account.

4. To determine the average score referred to in 1 paragraph 1 point 3), the rules applicable for calculating the average score for the purposes of awarding the Rector's scholarship for outstanding academic achievements shall apply accordingly.

5. The application for participation in the Competition should be accompanied by certificates, diplomas or certificates confirming specific achievements or student's activity.

6. Where the number of persons meeting the criteria referred to in section 1 is greater than the number of awards to be distributed, the person who has successively achieved the highest average grade and met the criterion of outstanding achievements or activity shall have priority in obtaining a prize.

7. The ranking list of persons shall be drawn up taking into account the total average of grades and outstanding achievements or activities.

§ 6

1. The condition of participation in the Competition by candidates to study at KA AFM is the submission of a completed and signed application for participation in the competition together with a signed consent for the processing of personal data and information concerning the processing of personal data (attachment no. 1) to the Recruitment Department of the Andrzej Frycz Modrzewski Krakow University, 1 Gustav Herling Grudziński Street, 30-705 Krakow, building C, by 15.09.2022.

2. The condition for KA AFM students to take part in the competition is to submit a completed and signed application for participation in the competition (with attachments) and a signed consent to the processing of personal data and information concerning the processing of personal data (attachment no. 2) to the appropriate Dean's office, by 15.09.2022. It is allowed to submit the application together with other documents via e-mail to the appropriate Dean's office.

3. Participation in the competition is voluntary and free of charge.

4. The employees of the Organizer or Founder and other entities involved in the implementation of the competition, as well as members of their families cannot participate in the competition.

5. Each Participant may submit only one application.

6. All costs related to the submission of the application shall be borne by the competition participant.

§ 7 Competition settlement

1. The competition will be resolved by the Competition Committee selected by the Organiser, consisting of 3 representatives of KA AFM, who will select 2 persons holding the best results from the high school graduation examination among those enrolled on the list of first year students of the first degree studies or master's degree studies conducted at the Andrzej Frycz Modrzewski Krakow University and will select 1 person from among those enrolled on the list of first year students or full-time uniform master's degree courses conducted at the Andrzej Frycz Modrzewski Krakow University, with a high average grade in the winter semester of the academic year 2021/2022 and outstanding achievements or activities.

2. The competition will be settled by 16.09.2022.

3. The Competition Committee will decide on the final settlement of the competition and awarding the prizes taking into account the fulfilment of the criteria specified in § 4 and § 5 of these Regulations. The jury will draw up a protocol of the competition settlement.

4. The competition participants will be informed about the results of the competition by phone or e-mail to the data provided in the application form.

5. The personal data of the competition participants who were selected for the award shall be transferred to the Founder in order to complete the formalities necessary to transfer the award.

6. Should the Winner resign from the prize awarded, the Competition Committee shall award the prize to the next person on the ranking list referred to in § 4 section 5 or §5 section 7 of these Regulations.

7. KA AFM shall not be liable for providing by the participant incorrect or untrue data which may make it impossible to provide the award by the Founder or may delay the process of the award provision.

§ 8 Personal data processing

In accordance with Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of data (...) ("General Regulation") The Andrzej Frycz Modrzewski Krakow University informs that:

I. The administrator of personal data is the Andrzej Frycz Modrzewski Krakow University, 1 Gustav Herling Grudziński Street , 30-705 Krakow.

II. The University has appointed a Personal Data Protection Inspector, who can be contacted in case of any questions or comments regarding the processing of personal data, at 1 Gustav Herling Grudziński Street in Krakow or via e-mail: iodo@afm.edu.pl.

III. Personal data will be processed for the purpose of organising and conducting the "LivinnX Five'Competition - pursuant to Article 6(1)(a) of the General Regulation - consent of the data subject.

IV. The provision of information is necessary to take part in the 'LivinnX Five' competition. The failure to provide the data will make it impossible to consider the application for participation in the competition.

V. Personal data may be provided or made available only to the entities authorized to do so under the law, in particular to the entities providing services to the University with respect to the IT infrastructure used. In case of awarding the prize, the personal data shall be transferred to the Founder on the basis of an agreement concluded between the University and the Founder on entrusting the processing of personal data.

VI. Personal data will be kept for the period of archiving under the compliance with the law.

VII. The competition participant has access to the content of their data and their correction, as well as the right to delete, limit the processing, transfer, object to the processing - in the cases and under the conditions specified in the General Regulation.

VIII. The contestant also has the right to withdraw their consent at any time without affecting the lawfulness of the processing that was carried out on the basis of the consent prior to its withdrawal. Withdrawal of consent to the processing of personal data can be sent by e-mail to the following address: iodo@afm.edu.pl or by regular mail to the address: 1 Gustav Herling Grudziński Street, 30-705 Krakow.

IX. Personal data will not be transferred to international organizations, nor be subject to profiling.

X. The Competition Participant has the right to lodge a complaint with the President of the Office for Personal Data Protection if they believe that the processing of their personal data violates the provisions of the General Regulation.

§ 9 Final provisions

1. These Regulations are available at the headquarters and on the website of the Andrzej Frycz Modrzewski Krakow University.
2. By entering the competition, the participant accepts the entire content of these Regulations and undertakes to observe them.
3. The organizer is not responsible for the consequences of the action or omission of third parties.
4. KA AFM reserves the right to make changes in these Regulations, at any time without giving any reason.
5. In all matters not regulated in the Regulations, the Organizer decides.
6. The final interpretation of the provisions of the Regulations falls under the Organizer's competence
